The Bexar County Tax Assessor-Collector's Office has received

NEW FOR 2018-2019

- Our office has begun assessing and collecting property taxes for the City of Fair Oaks Ranch and for the first time will now collect property taxes for ALL taxing jurisdictions in Bexar County.
- ▶ The County's First Drive-Thru will open soon at the Southside Tax Office located at 3505 Pleasanton Road.
- ► The City of Olmos Park has adopted a Tax Freeze for homeowners with a 65 and Over or Disability Exemption.
- ► The University Health System has adopted a \$10,000 exemption for 65 and Over qualifying residential homeowners.
- ➤ The City of Converse has increased the 65 and Over Exemption to \$15,000.

PROPERTY TAX PAYMENT PLANS FOR SENIOR CITIZENS, DISABLED CITIZENS, AND DISABLED VETERANS

QUARTER-PAYMENT PLAN

This four equal payment option is available to qualified property owners who have a Homestead Exemption and who also have a 65 and Over, Disabled Person, or Disabled Veteran Exemption.

 At least one-fourth of the total tax bill must be paid by January 31, 2019.

10-MONTH PAYMENT PLAN

This new <u>AWARD WINNING</u> ten equal payment option is available to qualified property owners who have a Homestead Exemption and who also have a 65 and Over, Disabled Person, or Disabled Veteran Exemption.

 Allows payments in ten equal monthly installments beginning in October and continuing through July.

AUTOMATIC PAYMENT DEDUCTIONS

- Allows for automatic payment deductions from credit cards, checking accounts, or savings accounts.
- Notification is sent by email 48 hours before a payment deduction is made.
- Enrollment or renewal can be done in person or initiated over the phone. (Enrollment consent forms are available online.)
- · Online enrollment will be available soon.

HALF-PAYMENT PLAN

The Half-Payment Plan is available to all Taxpayers and Business Owners for both real estate and business personal property accounts. Taxes are payable in two equal installments without penalty or interest if you pay the:

- 1st half by November 30, 2018; and
- 2nd half by June 30, 2019*.

(*Date extended to the next business day.)

PRE-PAYMENT PLAN

 Allows homeowners and businesses without a mortgage escrow account to pre-pay their taxes in monthly installments without penalty or interest.

ELECTRONIC STATEMENT

For your convenience, Bexar County Taxpayers have the option to receive Property Tax Statements via email. To register for this free, convenient, and environmentally friendly service, log on to our website at www.bexar.org/tax and select e-STATEMENTS from the Property Taxes drop-down menu.

Important: As per the Property Tax Code, failure to receive a tax bill, including a tax bill requested to be sent electronically, does not extend the due date.

BUSINESS RENDITION REMINDER

Business Personal Property Renditions must be filed every year by April 1st to avoid a 10% late reporting penalty. Forms can be found online at www.bcad.org.

PROPERTY VALUE PROTEST REMINDER

The deadline to appeal your property values with the Bexar Appraisal District is May 15th of every year. Form 50-132 can be found online at www.bcad.org.

IMPORTANT TAX PAYMENT DATES

OCTOBER 2018

Tax Statement mailing begins.

NOVEMBER 30, 2018

1st HALF-PAYMENT due.

JANUARY 31, 2019

Last day to pay 2018 tax bill without penalty and interest. (If an active lawsuit exists for a previous year, attorney fees are added to the 2018 tax bill on February 1, 2019.)

MARCH 31, 2019*

Last day to pay 2018 business personal property taxes without accruing attorney fees.

IUNE 30, 2019*

- 2nd HALF-PAYMENT due.
- Last day to make a payment arrangement for past due taxes in order to avoid attorney fees (if an active lawsuit does not exist).

(*Date extended to the next business day.)

OUARTER-PAYMENT DUE DATES**

- 1st QUARTER-PAYMENT due by: JANUARY 31, 2019;
- 2nd QUARTER-PAYMENT due by: <u>MARCH 31, 2019</u>*;
- 3rd QUARTER-PAYMENT due by: MAY 31, 2019;
- 4th QUARTER-PAYMENT due by: JULY 31, 2019.

(*Date extended to the next business day.)

**Taxpayers can still join the Quarter-Payment Plan in February, but with a 7% late fee. Thereafter, any late quarter-payment incurs a penalty of 6% for the first month plus 1% interest per month until paid in full.

Late payments are subject to the PENALTY and INTEREST SCHEDULE below:

Interest continues accruing at 1% per month until the account is paid in full.
